Welcome:

Welcome to Volume 23, Issue #1 of the Saskatchewan Railway Museum News.

The Association's publication has been in hiatus since September 2010 when health issues forced Bill and Ann Heselton to step down as editors. Since then, one reoccurring issue discussed at Board meetings has been the need to resurrect our Newsletter. Given the rich heritage and accomplished editors that we follow, we are truly humbled knowing that we have big shoes to fill.

We plan on publishing the Newsletter Quarterly, highlighting Museum activities, news and upcoming events. We also plan to have articles on artifacts at the Museum and hope that you will find it informative and interesting.

We also encourage members to submit articles, photos or information on a project or activity, after all this is your newsletter.

Did you know?

The first issue of the newsletter was edited by member and President of the SRHA James Brock of Saskatoon. It was distributed on the 15th of May 1988. James Brock transferred to Edmonton in 1990 and there was a brief period when the newsletter did not get published.

In the summer of 1991 P.J. Kennedy of Vanscoy, Saskatchewan took over the editor's role. For many years the newsletter was published quarterly under the banner The Prairie Switcher. On October 1st, 2001 the SRHA Board approved a change of name of the newsletter to Saskatchewan Railway Museum News. Kennedy held the editor's position until his resignation in the autumn of 2005.

In 2006 Bill and Ann Heselton of Moose Jaw took over the responsibilities of the newsletter and it was at this time that the newsletter was digitally prepared and distributed to members and friends of the Museum. Initially experimenting with some "Special Editions" and publishing six times a year, the newsletter, since 2008 was published quarterly until September 2010, Volume 22, Issue 3 being the last published by the Heseltons.

Annual General Meeting:

This year's SRHA Annual General Meeting was held at the J.S. Wood Library in Saskatoon on January 26, 2013 at 2:00 p.m., with 15 members in attendance.

The first order of business was the circulation, review and adoption of the minutes from the 2012 AGM, followed by the Treasures financial report. Lynda Thiesen (SRHA treasurer) reviewed the SRHA's 2012 finances, and presented a motion to waive the requirement for an audit following which a vote was held and carried.

This year, award presentations were made at the AGM as there would not be a banquet to follow. There was only one award that being the Friend of the Museum presented to the Saskatoon British Car Club, accepted on their behalf by Bill Rafoss. The award was to acknowledge club members Don Lumley, Ed Aldred and Logan Derksen for the work that they did repairing the Trackmobile.

Stepping down from the Board in 2013 was Ron Adams, who had served as a Director and Chairperson in his Board tenure. For his dedicated service on the Board, Ron was presented with an engraved tie spike acknowledging his contribution to the SRHA. Unfortunately Ron was ill and unable to attend the meeting, so SRHA Treasurer Lynda Thiesen accepted on his behalf.

Chairperson Cal Sexsmith presented his report on the state of the organization, highlighting this year's accomplishments and some of the objectives for 2013.

Annual reports were once again made available to members at the AGM. Below is a list of the reports submitted.

The new Board of Directors for 2013 will consist of existing directors Cal Sexsmith (Chair) and Terry Enns who have one year remaining on their two year term, and Keith Flory who agreed to serve another two year term. Former Directors Fred Tatler and Bill Rafoss will return to the Board, each serving a two year term. Norm Dyck is a first time Director, and will serve a one year term rounding out this year's Board.

Following the installation of Board members, Chair Sexsmith called for a motion to adjourn the AGM.

Following the AGM members were encouraged to stay around for a special meeting to discuss ways in which we could increase our membership.

Several good ideas were brought forward by members in attendance, including the idea of possibly having two types of memberships. Chair Sexsmith commented that other related organizations have different types of memberships one for Members and one for Volunteers as not all who join necessarily have the same interests. There was also discussion about the formation of a membership committee that would oversee the integration and retention of new and existing members.

At the end of the meeting there seemed to be agreement that we need to do more to integrate new members into the organization once they have joined, but we also need to ensure that we are finding way to engage and reactivate our existing members.

New Executive on track for 2013:

Following the AGM it is a requirement that the Board of Director appoint from within, one member to chair the Board. Cal Sexsmith the outgoing Chairperson was acclaimed for 2013, having assumed that role of Chairperson midterm in 2012 when Ron Adams stepped down for personal reasons.

Coming on the heels of the strategic planning meeting held September 22, 2012 The Board of Directors has committed itself to making Membership one of their highest priorities for 2013. To that end a Membership committee will be formed, with the sole purpose of ensuring that new and existing members to the Association feel welcome and connected to the organization.

Other changes happening at the Board level will be less obvious but no less important. Chair Sexsmith had proposed a realignment of Board responsibilities in areas within the organization. The rationale behind the realignment was to allow the Directors to focus their efforts in one area, and ensure that the membership will know who to contact if they wish to participate, have an issue with something that is being done or just want to make a suggestion or comment.
